# **COMPANY OFFICER ACADEMY**

### **COURSE SERIES DESCRIPTION:**

The Santa Clara County Training Officers would like to present the course curriculum for the 2018 Company Officer Academy. The following series of courses supports the educational knowledge base necessary for developing aspiring Company Officers. The curriculum identifies areas that are critical to the job description common to officers in the Operational Area. Students who register for the series will be required to complete all nine classes of instruction. Students who are not able to complete all nine classes will have the opportunity to make up missed classes the following year.

The course curriculum and month of instruction is listed below. Each course will have two separate dates of instruction during the month to allow students greater flexibility in scheduling.

- Leadership/Fire Chief's Panel (Palo Alto FD): January 23 or 26
- Basic Fire Investigation/Report Writing (Sunnyvale DPS): February 20 or 23
- FF Bill of Rights, Progressive Discipline, Performance Appraisals (Santa Clara County FD): March 20 or 23
- Command Operations (Moffett Field): April 17 or 20
- Ethical Leadership in the Classroom (San Jose FD): May 22 or 25

- Post Incident Analysis (Santa Clara FD): September 18 or 21
- Mutual Aid Communication Plan/EOC Operations (Milpitas FD): October 23 or 26
- MCI/Disaster Relief Response (Mt. View FD): November 13 or 16

  December 18 or 21

Classes are limited to 20 students per session of instruction with priority given to those students enrolled in the entire Company Officer series.
