VOLUNTARY SELF ATTESTATION

The purpose of this self attestation is to be able to assess the viability of a recruit being hired by a law enforcement agency upon successful completion of the POST basic academy. Due to the nature of law enforcement, agencies are mandated by POST to complete an extensive background investigation on a candidate prior to their being hired as a police officer or other law enforcement employee. We will use your answers on this form to determine if there are any areas which may raise a concern, and help you, if possible, take steps to recover from them.

When completing this form, it is essential that you be honest and complete in your answers. Answering "yes" to a question does not necessarily preclude you from entering a law enforcement career. Lying about an issue in your background, in all likelihood, will result in your being disqualified by most agencies. Since this document will be included in your student record, and thus be discoverable by a Law Enforcement Agency doing a background investigation, you must be truthful in answering these questions.

Filling out this self attestation form is entirely voluntary, and is not a condition of admission to or graduation from the academy.
